Website Privacy Policy - 1st ScotSail Training Limited

ScotSail is committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information. 1st ScotSail Training Ltd is referred to as 'ScotSail', 'we', 'us' or 'the Company' throughout all ScotSail publications, websites and usual sales literature.

(1) What information do we collect?

We may collect, store and use the following kinds of personal data: [(a)information about your computer and about your visits to and use of this website (including [your IP address, geographical location, browser type, referral source, length of visit and number of page views]);] [(b)information relating to any transactions carried out between you and us on or in relation to this website, including information relating to any purchases you make of our goods or services (including sailing courses, gift vouchers, yacht charters or any other products, goods or services sold by any ScotSail Group company). [(c)information that you provide to us for the purpose of registering with us [(d)information that you provide to us for the purpose of subscribing to our website services, email notifications and/or newsletters [(e)any other information that you choose to send to us; and] [(f)OTHER INFORMATION.]

(2) Cookies

A cookie consists of information sent by a web server to a web browser, and stored by the browser. The information is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser. We may use both "session" cookies and "persistent" cookies on the website. [We may use the session cookies to: keep track of you whilst you navigate the website; and OTHER USES.] We may use the persistent cookies to: enable our website to recognise you when you visit Session cookies may be deleted from your computer when you close your browser. Persistent cookies will remain stored on your computer until deleted, or until they reach a specified expiry date. We use Google Analytics to analyse the

asset which we are (or are contemplating) selling.] Except as provided in this privacy policy, we will not provide your information to third parties. (5) International Data Transfers

Information that we collect may be stored and processed in and transferred between any of the countries in which we operate in order to enable us to use the information in accordance with this privacy policy.
